- iii. The student should not be availing scholarship from other Corporate Company.



- **6. Selection procedure for award of the scholarship:** Each University is requested to short list 3 students. Final selection will be made by a Panel comprising of the University and a representative of the Parijat Company.
- 7. Tenure and other terms & conditions of scholarship: The scholarship shall be paid for 2 consecutive years and the payment of the scholarship shall be made to the selected students by cheques through the respective Universities. After completion of first year, the concerned University shall be required to furnish progress report to Parijat Industries (India) Pvt. Ltd. New Delhi for continuance of the scholarship for the second year. The scholarship shall be discontinued to those students who have failed to secure minimum70% marks in the first year examination.
- **8. Option to join the Company:** On completion of the Post-Graduation, the successful candidates availing Parijat scholarship may join the company, if so they desire, at a minimum pay of Rs. 15000/- per month as Trainees, provided there are vacancies.

In compliance to the decision of the 212th Board Meeting on held on 06.08.2016, Item No 9 the Guidelines for Dhanuka Agri-tech Fellowship on programme (2016-17) of JNKVV, Jabalpur, is as follows:-.

The guidelines for award of fellowship will be

- Fellowship will be known as Dhanuka Agritech fellowship
- The fellowship will be for the Department of Entomology at the University level.
- Rs. 10,000/- month Fellowship to be offer to a regular student admitted for M.Sc. (Ag) Entomology getting highest OGPA on the basis of First semester result of M. Sc. Previous for a period of two years.
- A contingency of Rs. 25,000/- will be provided in the final year.
- A student already availing any other Fellowship will not be eligible for this Fellowship.
- In the event of the student getting highest OGPA not accepting the fellowship, the offer will be open for next in the merit.
- Student failed in any subject (credit/non credit, major/ minor/ supported/ etc) will not be eligible for the fellowship.
- In case the Fellow drops from the Master's degree programme for any, reason, the Fellowship amount including Contingency will have to be refunded.
- The thesis topic will be decided by the University as per its constitution, however, Dhanuka Group consent may be obtained.
- The Fellow will be required to duly acknowledge in his/her thesis, Dahnuka Agritech. Ltd. For the Fellowship.
- Professor and Head Department of Entomology has to ensure submission of a copy of the accepted final thesis to Dhanuka Agritech Ltd.
- The fellowship amount will be credited to the University account for further disbursement to the Fellow.

Sir,

Please find enclosed herewith a D.O. letter No. 17011/02/2015-Edu dated the 15th July, 2016 stating therein that Aadhaar will be used as identifier for all Centrally Funded Scholarship schemes so as to facilitate direct and timely transfer of scholarship and thereby avoid hardships to genuine and deserving students. However, the other contents of the letter is self-explanatory.

As you are aware that Agricultural Education Division provides financial support to State Agricultural Universities/Deemed to be Universities/Central Universities located across the country through its Plan Scheme "Strengthening and Development of Higher Agricultural Education in India" under various components viz. National Talent Scholarships (NTS), STUDENT READY etc. Hence, it is, therefore, requested kindly to implement the instructions contained in the said DO letter dated 15.7.2016 henceforth accordingly

Dear Chief Secretary,

As you are aware, Aadhaar is being successfully used for Direct Benefit Transfer (DBT) in various Government schemes such as Pahal, MNREGA, PDS etc. It has now been decided that Aadhaar will be used as identifier for all centrally funded scholarship schemes so as to facilitate direct and timely transfer of scholarships and thereby avoid hardships to genuine and deserving students.

- 1.2 Applications for scholarship need to be submitted through a new National Scholarship Portal 2.0 (NSP 2.0) (http://scholarships.gov.in) where Aadhaar number of beneficiary would be mentioned while applying on the portal. For the two centrally sponsored scholarship schemes administered by this Ministry, viz Pre-Matric Scholarship Scheme and Post-Matric Scholarship Scheme for ST students, last date of applying on-line on the portal is 31st August, 2016. In view of this, it is necessary to facilitate students who are entitled for any scholarship for Aadhaar enrolment.
- 2.1 For Direct Benefit Transfer (DBT), bank accounts of scholarship holder will also have to be seeded with Aadhaar number. Tribal / Social Welfare Department in your State / UT is therefore requested to undertake (in a campaign mode) enrolment of students for Aadhaar so as to complete the process by end of July, 2016.
- 2.2 If there are large number of students in a school requiring Aadhaar number, then special camps may be organized in school to obtain biometric data. If the number to be covered is small, then scholarship holders may be taken by a teacher of the school to nearest Permanent Enrolment Centre of UIDAI for recording of biometrics. Once Aadhaar number is received, school may arrange to get consent forms of all scholarship holders for Aadhaar seeding of bank accounts, and send the same to concerned bank branches. Similar action is also required in respect of ST students studying in institutions (higher education) covered under Post-Matric Scholarship Scheme.

- 3.1 You are requested to issue instructions to all District Collectors to immediately organise meetings with officials of concerned Departments and start enrolment drive in a campaign mode with immediate effect.
- 3.2 Aadhaar enrolment of scholarship holders of two scholarship schemes indicated above must be completed by 31.7.2016 positively. Similarly seeding of their bank accounts shall be completed by 20.8.2016. In case student is already having Aadhaar number, then its seeding with respective bank account number must be done by 31st July, 2016.
- 4. Above mentioned exercise is required to be completed in a time bound manner as given hereunder:
- Seeding of existing Aadhaar numbers into bank accounts of students by 31^{ee} July 2016.
- (ii) Collection of biometrics for Aadhaar enrolment of students not having Aadhaar by 31st July, 2016.
- (iii) Seeding of Aadhaar numbers into bank accounts by 20th August, 2016.
- 5.1 You are requested to ensure that all applications for two Centrally Sponsored Scholarship Schemes of this Ministry (both new applications and for renewal of scholarships from previous years) are submitted into "Scholarship Portal" well before 31.8.2016.
- 5.2 If Aadhaar no. is either not linked to application form or not seeded to bank account, it may not be possible to ensure release of scholarship funds.
